PREFACE

The uses of climate information are evolving rapidly. In popular usage, climate refers to the average weather or its variations over a period of time. During the twentieth century, meteorologists greatly improved their skill in weather forecasting for relatively short time periods, such as out to a week. Their forecasts could be relied on by those making decisions about a wide variety of activities. Historically, however, public and private decisions about the weather over longer time periods—the climate—were based on a statistical analysis of weather records. Much has changed over the last two decades. Our ability to monitor and predict variations in climate has increased substantially. Growing knowledge of the causes and characteristics of seasonal to interannual variability and decadal-time-scale changes is being translated into useful long-lead-time forecasts and a greater capability to project future climate change. Those increases in capability coincide with a growing realization of the importance of climate variability and the potential for future change. The extension of climate information from a statistical analysis of historical observations to seasonal and interannual forecasts to century-scale projections has enabled a broader set of applications, which serve to enhance economic vitality, manage risk, protect life and property, promote environmental stewardship, and assist in the negotiations of international treaties. The array of applications and the potential for new applications are enormous.

PREFACE x

The provision of climate services in the United States is evolving in response to the combination of a growing knowledge base, a growing appreciation of the importance of climate in human endeavors, and a greater demand for climate information. Two issues emerge. First, the value of these services to society depends on many factors, including the nature of uncertainties of the forecasts and projections, the strength of the connections between climate and specific human endeavors, the accessibility of the information, and the ability of users to respond to useful information. Second, the importance of climate is clearly stimulating user demand and broadening the scope of and demand for climate services. For this reason, the Federal Committee for Meteorological Services and Supporting Research asked the Board on Atmospheric Sciences and Climate (BASC) of the National Research Council to review the status of climate services in the United States and to recommend direction for the future provision of these services. That request matched the list of topics identified by BASC as priority subjects for study after its 1998 review of the field of atmospheric sciences. The federal agencies responsible for climate services developed a statement of task, and in response the board reviewed the provision of climate services in the United States.

The report that follows is divided into four main segments. Chapter 1 provides specific examples that show the growing breadth and demand for climate services in the United States. The evolution of climate services is examined in Chapter 2 by briefly reviewing its history and the current activities of U.S. agencies. The board developed a set of principles that should guide the provision of climate services; these are presented in Chapter 3. Finally, the board's recommendations focus on enhancing existing institutional capabilities. The recommendations, laid out in Chapter 4, reflect a set of "first steps" to a more effective climate service in the United States. The intent of the recommendations is to promote a climate service that is increasingly user-centric, that reflects the value of both historical and predictive knowledge, and that promotes active stewardship of climate information. The board believes that its recommendations can be implemented quickly and that they have the potential to pay large dividends at modest cost because they leverage current climate service efforts. At the same time, the guiding principles should continue to help promote a highly valued and useful climate service function in the United States even beyond these first steps.

EXECUTIVE SUMMARY

Climate¹ is an increasingly important element of public and private decision making in fields as varied as emergency management planning for increased threats of hurricanes or severe storms and energy-production requirements for the coming season. Advances in capabilities to monitor and predict variations in climate, coupled with growing concern over the potential for climate change and its impact, are yielding an increased awareness of the importance of climate information for enhancing economic vitality, maintaining environmental quality, and limiting threats to life and property (Changnon 2000).

Historically, climate services have revolved around the statistical analysis of existing weather records. Today, however, the science and understanding of global and regional climate have gone well beyond a statistical analysis of historical records. Research efforts of the last two decades have produced substantial improvements in understanding short-term climatic fluctuations such as El Niño and La Niña (NRC 1996). A number of groups around the world now regularly forecast aspects of the El Niño/Southern Oscillation phenomenon

and its associated impacts. Increasingly, climate model projections are also being used by decision makers to assess long-term global change issues of importance to the nation. After reviewing the various meanings used in the past, the National Research Council's Board on Atmospheric Sciences and Climate (BASC) took a broad view and defined *climate services* as the timely production and delivery of useful climate data, information, and knowledge to decision makers.

A climate service must focus on very different types of activities in order to address all the major categories of variability and change. Climate services and products include observations, forecasts, and projections and their uncertainties that address both seasonal to interannual variability and decadalto century-scale change and variability, including human-induced global change. Each is associated with different types of users or decision makers and with different types of needs and products, as is evident by the current use of climate information.

The value of climate information to society depends on many factors, including the strength and nature of the linkages between climate, weather, and human endeavors; the nature of the uncertainties associated with climate forecasts; the accessibility of credible and useful climate information to decision makers; the ability of users² and providers to identify each other's needs and limitations; and the ability of users to respond to useful information. Increasing realization of the importance of climate is stimulating user demand for improved information, which in turn is substantially broadening the scope of climate services. Because of these factors, the subject of climate services was an agenda item at the fall 1999 BASC meeting, held jointly with the Federal Committee for Meteorological Services and Supporting Research (FCMSSR). Subsequent to the meeting, the federal agencies, through FCMSSR, asked BASC to review the status of climate services and to recommend direction for the future provision of climate services to the nation. In particular, BASC was asked to address the following items outlined in the statement of task:

- Define climate services.
- Describe potential audiences and providers of climate services.

- Describe the types of products that should be provided through a climate service.
- Outline the roles of the public, private, and academic sectors in a climate service.
- Describe fundamental principles that should be followed in the provision of climate services.

This report summarizes BASC's response to the task statement. BASC reviewed the subject at its spring 2000 meeting, at which it planned the details of a workshop that was held August 8–12, 2000, in Woods Hole, Massachusetts. Following the workshop, BASC dedicated a full day of its fall 2000 meeting to final deliberations and report preparation.

BASC assessed the current climate service activities in the United States and compared the state of climate services with the development of weather services to identify the following five guiding principles for climate services:

- 1. The activities and elements of a climate service should be usercentric.
- 2. If a climate service function is to improve and succeed, it should be supported by active research.
- 3. Advanced information (including predictions) on a variety of space and time scales, in the context of historical experience, is required to serve national needs.
- 4. The climate services knowledge base requires active stewardship.
- 5. Climate services require active and well-defined participation by government, business, and academe.

RECOMMENDATIONS

The goals of the following recommendations are to enhance the capabilities of existing institutions and agencies and to build a stronger climate service function within this context. Therefore, these recommendations constitute the "first steps" that can be taken immediately to enhance the effectiveness and efficiency of U.S. climate services rather than to reorganize existing activities. These first steps are designed to develop and provide climate services that are user-centric, that reflect the value of both historical and predictive knowledge, and that promote active stewardship of climate information. Taking

these steps will pay large dividends at relatively modest $cost³$ because several of the elements that are needed for climate services already exist. Furthermore, such recent advances in technologies as the Internet, data storage, and computing make possible economies that could not have been realized even a few years ago.

1. PROMOTE MORE EFFECTIVE USE OF THE NATION'S WEATHER AND CLIMATE OBSERVATION SYSTEMS.

Recommendation 1.1: Inventory existing observing systems and data holdings. Each agency should identify its climate-related observing systems and data holdings. For each observing system, the agency should identify (1) what purpose each set of observations and data serves for the provision of climate services, (2) how each observing system addresses user needs, (3) how each system is managed, and (4) what considerations govern decisions regarding the observing systems. The Office of the Federal Coordinator for Meteorology (OFCM) should be considered as an agent for this recommendation.

Recommendation 1.2: Promote efficiency by seeking out opportunities to combine the efforts of existing observation networks to serve multiple purposes in a more cost-effective manner. Strong interagency leadership is essential for creating a cost-efficient and cost-effective observing system. Again, this seems to be an appropriate activity for the OFCM.

Recommendation 1.3: Create user-centric functions within agencies. A truly useful climate service depends on having mechanisms that support and enable user-centric design and improvement. These include effective means for encouraging dialogue with users, the willingness to adapt existing data types and formats to meet specific user needs, and the availability of expertise in the operations of the various major user groups being supported within the climate service organization.

Recommendation 1.4: Perform user-oriented experiments. A partnership of providers and users should be empowered to propose and execute experiments designed to promote and assess the use of climate information.

Recommendation 1.5: Create incentives to develop and promote observation systems that serve the nation. Currently across the nation there is a wide disparity in efforts to establish local-level weather and climate networks that augment stations run by federal agencies and are established to aid local and state decision-making.

2. IMPROVE THE CAPABILITY TO SERVE THE CLIMATE INFORMATION NEEDS OF THE NATION.

Recommendation 2.1: Ensure a strong and healthy transition of U.S. research accomplishments into predictive capabilities that serve the nation. The United States has a strong atmospheric and oceanic research community. However, there is a need to enhance the delivery of products useful to society that stem from this investment in research.

Recommendation 2.2: Expand the breadth and quality of climate products through the development of new instrumentation and technology. New instrumentation and technology should be viewed in terms of the expected expansion of the forecasting/prediction family into the areas of air quality, hydrology, and human health. To support new modeling and analysis capabilities and to support and improve the existing climate database, it is necessary to continue to improve upon existing sensors and their instrumentation and to develop new ones.

Recommendation 2.3: Address climate service product needs derived from long-term projections through an increase in the nation's modeling and analysis capabilities. There is a need to support a stronger role by the nation's modeling and analysis centers in the climate services related to long-term prediction. In particular, the centers should play a role in the development of the capabilities required to provide long-term simulations, analyses of limitations and uncertainties, and specialized products for impact studies.

Recommendation 2.4: Develop better climate service products based on ensemble climate simulations. There is a need for ensemble

seasonal to interannual forecasts and climate simulations based on multiple emission scenarios that can be devoted to studies of climate impacts, vulnerabilities, and responses. This will require dedicated resources for developing ensemble climate scenarios, high-resolution models, and multiple emission scenarios for impact studies.

3. INTERDISCIPLINARY STUDIES AND CAPABILITIES ARE NEEDED TO ADDRESS SOCIETAL NEEDS.

Recommendation 3.1: Develop regional enterprises designed to expand the nature and scope of climate services. The nation should develop a program of regional entities (laboratories or centers) that emphasize region-specific observation, integrated understanding, and predictive capability to provide useful information that will drive the development of a regional focus on addressing societal needs.

Recommendation 3.2: Increase support for interdisciplinary climate studies, applications, and education. It is essential to provide support to foster both the capacity for making and the ability to beneficially use climate products that are based on data, information, and knowledge from many disciplines (e.g., combining physical, chemical, biological, and societal stressors⁴ to yield products that explore climatological variability and societal impacts).

Recommendation 3.3: Foster climate policy education. Universities should initiate majors and minors in climate policy to enable informed planning and management of climate services. These programs should include education in the basics of climate science, identification of the needs of various user communities, and the creation and dissemination of climate information in forms that will be most useful to those users.

Recommendation 3.4: Enhance the understanding of climate through public education. Climate is increasingly important in decisions made by individuals, corporations, cities, states, and the nation as a whole. Critical to the successful application of climate information is an educated user.

BASC did not explicitly explore a formal climate services organizational structure within a specific federal, state, or local agency. Several such proposals internal to the government have been made in the past. One of note is the *NOAA Climate Services Plan* (Changnon et al. 1990), which offers several suggestions for consolidating the National Oceanic and Atmospheric Administration climate organizations, the Climate Prediction Center and the National Climatic Data Center, with the regional climate centers (RCCs) to form a unified climate service.

The existing network of state climatologists, RCCs, national agencies, and private sector organizations has provided services in the past and provides increasingly competent services today. BASC believes that the principles discussed in this report represent the best practices of the various activities and that if applied across all levels of service—local, state, regional, and national would improve the overall climate services to the nation. The recommendations contained in this report offer concrete first steps toward a better integrated national system.

Climate is an increasingly important element of the public and private decision-making process. Advances in monitoring and predicting variations in climate, coupled with growing concern over the potential for climate change and its impact, are yielding an increased awareness of the importance of climate information for enhancing economic vitality, maintaining environmental quality, and limiting threats to life and property (Changnon 2000). The importance of climate information has fostered the concept of a "climate service".

Climate has a local- to regional-scale component, and information and expertise are needed to address these space scales. For example, the climate of urban St. Louis is markedly different from that of rural Missouri, and the climate of the Midwest is strikingly different from that of the High Plains and the Northeast. Most activities impacted by climate operate at such local to regional scales and so need information for those areas. To serve the many agricultural interests in the Corn Belt, the Midwestern Regional Climate Center

has developed an operational on-line climate-crop yield model. Users can call in any time during the corn (or soybean) growing season and get up-to-date information on the status of climate conditions for their area of concern—say, southeastern Indiana. They can then examine a variety of climatologically-based choices for weather conditions during the remainder of the growing season. And finally they can obtain crop-yield estimates based on what has already occurred and what might occur.

Historically, climate services have revolved around the statistical analysis of existing weather records. This information formed a useful basis for estimating future agricultural production and energy needs. Information on extreme events, such as "100-year floods" and peak wind speeds, continues to be critical in the design and construction of major facilities such as dams, highways, and buildings. In 1922, for example, the division of water allocations between states in the Colorado River Basin (the Colorado River Compact) was based on historical observations for a time of anomalously high flow, compared with later years. The allocations were based on a ten-year period to even out natural variability but could not incorporate longer time-scale variability. The Mexican Water Treaty of 1944 controls the allowable salinity and volume of water entering Mexico from the United States. The system of dams constructed along the Colorado River allows storage of four times the average annual flow as a hedge against low-flow years and as a means to maintain treaty requirements. Historical climate records are also used to set "safe" levels of water storage and prevent emergency water releases that would cause downstream flooding (e.g., Rhodes et al. 1984). The availability of the various sources of climate information and products summarized in this example has historically been supported through many federal, state, and local agencies and represented a climate service to the nation. In recognition of the growing importance of this service, the National Oceanic and Atmospheric Administration's (NOAA) National Climatic Data Center (NCDC) in Asheville, North Carolina, was founded in 1951 as the U.S. Weather Records Center.

Today, however, the science and understanding of global and regional climate have gone well beyond a statistical analysis of historical records. Research efforts of the last two decades have resulted in a substantial improvement in our understanding of short-term climatic fluctuations such as El Niño and La Niña (NRC 1996). A number of groups around the world now regularly forecast aspects of the El Niño/Southern Oscillation (ENSO) phenomenon and its associated impacts. In many regions, the impacts of ENSO are increasingly anticipated by decision makers as a result of forecasts that are

taken seriously and serve as input for decision strategies and choices (Changnon 2000).

In April 1997, record flooding along the Red River of the North and in Grand Forks, North Dakota, resulted in \$2 billion in damages. The magnitude of the damages was especially surprising given that the record flood was anticipated a season in advance. In February 1997, the U.S. National Weather Service issued a flood outlook for Grand Forks for the coming spring flood season warning residents to expect a flood of record, 49 feet, sometime in mid-April. While the 3-month outlook was within 10 percent of the actual flood crest—highly skillful by any measure of predictive accuracy—neither forecasters nor local residents fully understood the degree of uncertainty in the flood outlook (e.g., as to the timing and height of the water crest, the duration of the highest water, and the area covered by the flood). Consequently, preparations to fight the flood placed an improper precision on the 49-foot outlook, leading to surprise and then anger when the river's crest exceeded that level (Hooke and Pielke 2000).

The Grand Forks experience and many similar experiences send a twopronged message. On the one hand, they provide optimism that forecasters can produce skillful predictions and other information on seasonal (and longer) time scales. On the other hand, they suggest that the effective use of the information is not always straightforward. As knowledge of climate and the use of climate information have developed, both the challenge and promise of providing operational "climate services" have become readily apparent. It is time to focus on the challenge of providing climate services to realize the promise that they hold.

The combination of historical observations, paleoclimate data, and efforts to develop a hierarchy of coupled models is increasing the understanding of the causes and character of climate fluctuations, although the nature of decade to century climate variability remains an important topic of research (NRC 1995, 1998c). From such research, a growing appreciation has emerged that "climate" can no longer be considered stationary—climate changes, sometimes dramatically, over periods of years to decades. Within the last two decades, concern about the potential of human-induced changes in the earth's climate has resulted in the development of new methods for observing the earth system and in better understanding of the possible courses of future climate. These developments and advances are in large part the result of core research in the atmospheric, oceanic, and biological sciences and are the research foci of the U.S. Global Change Research Program (USGCRP 2000). The increased

understanding of the climate system has provided greater knowledge of the variations recorded by historical measurements. The tools developed for experimental long-lead-time forecasts (a month to a year) now permit experimental predictions of seasonal to interannual climate patterns and a limited but growing capability to project future climate changes. The societal value of such information depends on many factors, including the following:

- The strength and nature of the linkages between climate, weather, and human endeavors.
- The nature of the uncertainties associated with climate forecasts.
	- The accessibility of credible and useful climate information by decision makers.
- The ability of users and providers to identify each other's needs and limitations.
- The ability of users to respond to useful information.

Increasing realization of the importance of climate is stimulating user demand for improved information and substantially broadening the scope of climate services. Because of these factors, the subject of climate services was an agenda item at the fall 1999 meeting of the Board on Atmospheric Sciences and Climate (BASC), held jointly with the Federal Committee for Meteorological Services and Supporting Research (FCMSSR). Subsequent to the meeting, the federal agencies, through FCMSSR, asked BASC to review the status of climate services and to recommend directions for the future provision of climate services to the nation. In particular, BASC was asked to address the following items outlined in the statement of task:

- Define climate services.
- Describe potential audiences and providers of climate services.
- Describe the types of products that should be provided through a climate service.
- Outline the roles of the public, private, and academic sectors in a climate service.
- Describe fundamental principles that should be followed in the provision of climate services.

This report summarizes BASC's response to the task statement. The board's efforts included a discussion of potential topics at its fall 1999 meeting; organizational discussions and preliminary briefings at its spring 2000 meeting;

an information-gathering activity during a workshop held August 8–12, 2000, in Woods Hole, Massachusetts; and additional discussion and review of materials at the fall 2000 meeting that followed the workshop.

CLIMATE SERVICES DEFINITION

Unlike climate services, the concept of a "weather service" is familiar to most citizens. A weather service focuses on the description, analysis, and forecasting of atmospheric motions and phenomena on very short times scales, extending up to a period of one week to ten days. The objective is to provide forecasts of continually changing weather and warnings of severe weather events. The benefits of this service are measured in lives saved, injuries avoided, or reduction in property damage. The National Research Council (1998a) has noted that this service is provided by a four-way partnership in which (1) the government acquires and analyzes observations and issues forecasts and warnings, (2) the government, newspapers, radio, and television participate in the dissemination of weather forecasts and severe-weather warnings, (3) private meteorological firms use government data and products to provide weather information for the media and special weather services for a variety of industries and activities, and (4) government, university, and private-sector scientists work to develop improved understanding of atmospheric behavior and turn it into new capabilities.

In contrast to weather, climate is concerned with the longer-term statistical properties of the atmosphere—ocean—ice-land system. Climate refers to the many statistical properties of such variables as temperature and precipitation over a specific region, the range of values of these variables, and the frequency of particular events as a function of location, season, or time of day. Climate variability and change are products of external factors, such as the sun; complex interactions involving the different components of the earth system; and humaninduced (or anthropogenic) changes to the earth system. Following the World Climate Research Programme, BASC (NRC 1998a) adopted three general categories of climate variability and change: seasonal to interannual variability, decadal to century climate variability, and changes in climate induced by human activities, such as emission of greenhouse gases. A climate service must focus on very different types of activities to address all of these major categories of variability and change. Each of the activities is associated with different types of users or decision makers and with different types of needs and products, as is evident by the current use of climate information.

The earliest climate services consisted of descriptive information and statistical analyses of weather observations. The statistical analyses of the weather data evolved in response to the needs of engineers, designers, and insurers. Seasonal to interannual forecasts developed over the last few decades have generated additional demands for information and products. The value of the information is a function of the ability of the various sectors (e.g., agriculture, water, energy, transportation, and health care) to use climate information a season to a year in advance. The assessments of long-term potential changes in the global and regional climates as a result of anthropogenic factors add to the demands and variety of potential climate services. This information is being used by national and international policy makers and in a variety of long-range planning activities.

BASC reviewed the evolution of climate services in the nation (see Chapter 2) and examined the various definitions of *climate services* that have been used in the past. In reviewing the breadth of useful climate information—from historical analyses to century-scale predictions—BASC chose to be inclusive by adopting the following definition of *climate services:*

The timely production and delivery of useful climate data, information, \overline{a} $maxers.$

EXAMPLES DEMONSTRATING THE BREADTH AND DEMAND6 FOR CLIMATE SERVICES

The demand for and use of climate services has grown substantially over time. For example, NCDC now provides 120 major data sets and products online that describe a variety of climate elements. Since the initiation of the online data system in January 1998, orders have steadily increased to a rate of 1,800–2,000 requests per month. A profile of off-line orders reveals a customer base of about 77 percent business, 13 percent government, and 7 percent individuals (Karl 2000). Products of the NOAA Climate Prediction Center (CPC) include both extended weather outlooks and climate information. The most popular of the climate products include an ENSO Diagnostic Advisory, 30- and 90- Day Outlooks, long-lead-time (out to 13 months) outlooks, a U.S. Drought Assessment, and an Atlantic Hurricane Outlook. Users of NOAA's specialized data products include FEMA; the American Society of Heating, Refrigerating, and Air-Conditioning Engineers (ASHRAE); the Nuclear Regulatory Commission; and the National Association of Home Builders (NAHB). For example, NAHB uses temperature data when revising building codes. The airfreezing index can be used in conjunction with soil properties and surface ground cover to compute the ground freezing potential for particular areas and guide codes on building foundations. According to a U.S. Department of Housing and Urban Development study (HUD 1993), the revised building codes could result in annual savings of \$300 million in building costs. ASHRAE is using NCDC temperature, humidity, wind speed, and solar insolation data with the goal of reducing user energy consumption by 50 percent. The U.S. Navy now uses monthly and seasonal climate outlooks to control the large heating systems on its installations, resulting in a savings of \$65 million in utility costs (Cuff 2000). Previously, the dates for turning on the

The government provides the basic weather and climate services in this country, and so the usual demand—price relationship does not exist. The many *customers* of weather and climate services express their needs and desires for information that will improve their operations. heating and cooling systems were determined using the average climate conditions for a particular region.

The practical use of climate information extends well beyond the long lead time (13 months) of the NOAA products described above. For example, the Navy has entrained long-term climate-model projections with Arctic sea ice models in its long-range planning for fleet appropriations and construction. Other enterprises with long lead times—including construction of offshore drilling rigs, planting of timber, and development of transportation options— have also included climate change projections in their decision making.

A wide variety of cases demonstrate positive outcomes or reduced risk when climate information is incorporated into the decision-making process. However, because a comprehensive survey of such cases is not possible, this report cannot assess the magnitude of the value and importance of climate services. Instead, four examples have been selected from those investigated by BASC to illustrate of the breadth and character of the growing demand for climate services. The examples were selected to show the expansion of climate services from statistical analyses to more sophisticated products, including prediction as well as the range of partnerships involved in providing and accessing climate services. The first two examples, (1) coastal exposure and community protection from severe storms and (2) weather derivatives, describe services built directly on analyses of historical observations but for which there is a growing demand for enhanced predictive capability. The third example, based on ENSO forecasts, directly examines the importance of seasonal to interannual forecasts. The fourth example, based on the recent U.S. assessment of future climate impacts, considers the value of longer-term climate projections. In addition to showing both the breadth of and growing demand for climate services, the examples guide several of the recommendations in this report. Many more examples could be cited as well, involving, for example, waterresource management, water quality —climate connections, droughts and agriculture, and human health.

1. Climate information for the control of risks in coastal communities. Historical averages of weather data have been used in many applications throughout the nation. For example, the historical record shows that more hurricanes hit southern Florida than any other part of the country, prompting that region to write the nation's most stringent building codes. However, Hurricane Andrew, which crossed southern Florida in 1992 as a powerful category 4 storm, dramatically changed the risk and vulnerability perceptions of

residents, governments, builders, and insurance companies. FEMA's Federal Insurance Administration has identified outdated codes and a wide variety of inadequacies in construction, code enforcement, inspection, and training. Insurance industry experts estimated that up to 40 percent of the insured damages could have been avoided if building codes that were developed using more accurate climate information had been enforced (Pielke and Pielke 1997). The fact that damages were much greater than expected (an estimated \$15.5 billion in insured damages and total damages about twice that) has also resulted in revised estimates of coastal damage potential, with numerous eastern seaboard cities' insured-loss projections exceeding \$50 billion for a category 4 or 5 hurricane (Insurance Research Council 1995). Substantial savings can be realized if building codes that take improved climate data into account are adopted by builders and enforced. However, an ability to anticipate risk and vulnerability also has potential value.

Both societal exposure (coastal population growth and wealth) and the climatological understanding of the frequency and intensity of weather hazards are of major importance to the insurance industry (e.g., Munich Re 1994, Berz 1993, Dlugolecki 1992). The industry cannot provide coverage blindly and therefore must base the price and scope of underwriting on an assessment of potential liability. The potential liability of the industry has typically been based on a statistical analysis of past events to determine the probability of future events and on a geographic assessment of a variety of various liability categories. Those factors are combined to determine loss ratios. Both likely loss and probable maximal loss are important. Over the last several decades there has been significant growth in insured losses. Typically, changes in premiums and in scope of underwriting do not occur until after a substantial payment of claims. However, the increased insured losses have prompted the insurance industry to examine all aspects of its liability, including those dealing with changing climate patterns—either natural variability or longer-term climate change. The key issues identified by the industry are how weather changes with seasonal to decadal variations, whether climate change will be associated with new extremes, and whether changes in weather patterns due to seasonal to decadal variability or climate change will result in changes in the geographic location of exposures or the intensity or frequency of events. Hence, the role of climate services has been extended from a statistical analysis of the historical record to one in which understanding of climate variability and change in the context of population and demographic shifts becomes of substantial importance to governments and industry. The insurance industry, particularly the

reinsurance portion of the industry, seeks better climate information and outlooks so it can better manage its exposure. In addition, the insurance industry has established, as a priority, programs to mitigate the loss of life and property. Improved climate information assists the industry in planning for those important activities.

2. Weather Derivatives. Weather derivatives are financial instruments designed to allow businesses sensitive to the vagaries of weather to protect themselves against loss from changes in costs and sales linked to variations in climate. They gained in popularity during the winter of 1998–99 when long-range forecasts called for warmer than normal weather during that period (due to the onset of El Niño). Weather derivatives can theoretically be designed for almost any weather variable (e.g., rain, snow, and wind), although most of the activity so far has been based on temperature. They are quite different from insurance in that insurance is based on the willingness of individuals or corporations to pay a premium to transfer risk. The premium is based on weather statistics and a potential damage function, and the payout from the insurance reflects actual damages incurred. However, for many enterprises weather risk is defined by its impact on performance rather than on loss of property (e.g., impact on production rates, product availability, pricing, and product demand). The number of industries whose performance is impacted by weather and climate is large (WeatherRisk 2000). For example, moisture availability is a key factor in agriculture; under adverse growing conditions, the largest corn-producing counties in the nation can experience 30 percent reductions in yield. Agrochemical industries are also impacted; for example, weevils cost cotton growers \$300 million annually, and weevil severity is directly correlated with mild winter conditions. Viticulture has a strong climatological signal, with a lack of sunshine and cool temperatures from pre-bloom to maturation producing poor grape years and excess precipitation causing grape rot. The 1998 California grape harvest was 30 percent lower than the norm because of poor weather conditions. Beverage consumption and ice-cream sales are strongly correlated with warm temperatures. Clothing retailers are recognizing correlations between summer and winter sales volume and the magnitude of the departure from normal weather conditions. Amusement parks' profit margins are defined by peak attendance days associated with good weather. The construction industry often experiences penalties of 10–15 percent of job costs for delays related to, for example, temperatures needed for concrete to set,

The key to the growth of a weather derivatives market is that weather risk has differential impacts in terms of costs and benefits—a two-way flow of risk promotes the concept of trading risk. High snow accumulation aids a ski resort by increasing profits, but it substantially increases the cost of snow removal in cities. Hot summer conditions can increase power demand by a factor of 20 at greatly increased costs. Heat stresses livestock and agriculture, but it aids the beverage, ice cream, and summer clothing industries. Large fluctuations in performance associated with weather and the differential nature of impacts are fostering a weather derivatives industry. Weather derivatives add stability because during optimal conditions profits are high, so paying for the derivatives is not a burden. During poor conditions, the payout from derivatives helps to maintain cash flow and profitability, so risk is managed.

The first transaction in the weather derivatives market took place in 1997. In 2000, between 2,500 and 3,000 weather-related contracts were issued in the United States, with a total value of \$2.5 billion (PricewaterhouseCoopers 2001). The Weather Risk Management Association commissioned a recently completed survey by PricewaterhouseCoopers to determine the exact state of the weather derivatives industry (see <http://www.wrma.org>). EnronOnline (<http:// www.enrononline.com>), an Internet weather derivatives leader, currently has a contract portfolio of \$5 billion. The largest economic sector involved is energy because of the strong and obvious links between temperature extremes and energy demand, but both the number and scope of companies have been increasing since 1997 (including such new fields as leisure and home improvement). Some changes that are occurring in climate services are helping the growth of the weather derivatives industry. These include the availability of NCDC databases; the formation of private climate service companies that provide clean, standardized data directly for weather risk assessment at a large number of locations; the development of stochastic modeling tools as an aid in risk analysis; and the development of operational seasonal forecasts at the NOAA National Centers for Environmental Prediction (NCEP), particularly involving ENSO (WeatherRisk 2000).

3. The applications of regional ENSO forecasts. The 1925–26, 1972–73, and 1982–83 El Niños, which resulted in dramatic changes in rainfall and flooding, are examples of short-term climate events that had substantial societal impacts. The magnitude of ENSO and its impacts, a growing observational

and modeling capability, and a desire to better understand the role of the tropics in governing climate variability resulted in the development of the 10-year Tropical Ocean Global Atmosphere program. Important outcomes of that effort have been the development of a tropical observing system in the Pacific Ocean and some demonstrated skill in producing El Niño forecasts. NCEP's CPC is now experimenting with the use of coupled ocean-atmosphere forecasts, together with several statistical techniques, to arrive at an official consensus El Niño forecast with a lead time of two seasons. The scientific community is far from demonstrating skill in predicting all the features of ENSO (e.g., onset, duration, amplitude, and decay). However, once the El Niño is under way, the tendency for it to persist into the boreal winter results in substantial capability to anticipate and plan for many of its effects (Landsea and Knaff 2000).

Such investigations are just beginning in the United States, but such El Niño events as those of 1997–98 provide the opportunity to demonstrate the potential value of an increased ability to anticipate climate phenomena. The CPC correctly forecasted six months in advance the increased precipitation and storms across California, the southern plains, and the Southeast and a warmer winter in the northern tier states. An analysis of the losses and benefits associated with the 1997–98 event is instructive (Changnon 1999). In response to the 1997 climate predictions and on the basis of knowledge gleaned from the 1982–83 El Niño, FEMA initiated several mitigation activities, particularly in California and Florida. For example, California spent \$7.5 million on flooding-landslide preparedness efforts and alerting the public, and the roofing and home repair industry reported \$125 million in completed mitigation activities (Changnon 1999). The U.S. Geological Survey and the Bureau of Reclamation used the forecasts to guide water management in western systems. A number of northern utility companies used the forecasts to guide oil and natural gas purchases. For example, three utilities in Iowa and Michigan saved \$39, \$48, and \$147 million through fuel purchase planning (Changnon 1999). Although it is difficult to estimate, 161 fatalities and \$2.2 billion in losses were attributed to the 1997–98 El Niño in the United States (Changnon 1999). Of note, the losses in California were estimated (Changnon 1999) to be half those of the 1982–83 El Niño, suggesting that the extensive mitigation efforts were extremely beneficial. The impacts of ENSO variability and the potential savings resulting from the effective use of forecasts of ENSO events cover many areas, including agricultural production, coastal fisheries, emergency preparedness, systems for early warning of droughts, strategies for hydro

electric power generation, insurance concerns, and mitigation of forest fires (NRC 1996).

4. International and national assessments of the impacts of future climate change. The Intergovernmental Panel on Climate Change (IPCC) was established by the World Meteorological Organization and the United Nations Environment Programme to assess the science of climate change. The IPCC is charged with generating an assessment of the state of knowledge of climate change every five years. A critical product of this process is the *Summary for Policymakers,* which details the elements of the assessment deemed most significant for national and international decision makers. The IPCC has become a standard by which governments assess the implications of climate change, and IPCC reports underpin international negotiations on climate change and carbon emissions. In the *Summary for Policymakers,* the IPCC identifies the importance of the maintenance and improvement of the global observing system, the monitoring of key climate elements, the incorporation of prehistorical data into the examination of the climate record, the development of comprehensive climate models, and focused process studies as the foundation for advice to policy makers (IPCC 2001). The United States, as directed by the Global Change Research Act of 1990, has also undertaken a National Assessment of Potential Consequences of Climate Variability and Change, a landmark effort to examine the potential consequences for the regions of the nation, including coastal regions, and for forestry, water, agriculture, and human health. The historical record and the results from global climate models act as the foundation for stakeholders to assess the implications of climate change and then to consider adaptation strategies (USGCRP 2001).

Unlike earlier reports, the National Assessment does not analyze the potential for climate change. Instead, climate information is the basis for examining consequences of and vulnerabilities to climate change. A number of the consequences have important economic and quality-of-life implications. Climate modeling and analysis are the foundation for developing climate scenarios that describe alternative futures for analysis of potential consequences of climate change, potential adaptation options, and ultimately the vulnerability of communities, institutions, sectors, and regions. In addition, there is a call for greater emphasis on sustained quality-controlled observations. The assessment process reflects a growing need by decision makers and stakeholders for future climate information. In this important context, the climate observing

system and the national capability to provide nature climate projections represent a climate service to the nation (NRC 1998b, 2001b; USGCRP 2000).

SUMMARY

Climate information is increasingly important to the decision-making needs of a wide variety of users. The range of applications is enormous and indicates the impact of climate services. Applications include such diverse entities as water set-asides for instream flows to protect ecosystems, state and national water compacts, building codes, insurance premiums, irrigation and power production decisions, beverage consumption rates, retail clothing volumes, and construction schedules. The applications are also growing with the increased understanding of how climate influences human endeavors. That a weather derivatives industry, designed to manage risk associated with climate variability, is growing rapidly and expanding to include diverse elements of commerce and industry is indicative of the importance of climate services to the nation. The extension of climate capabilities from a relatively straightforward, statistical analysis of historical observations to seasonal and interannual forecasts and to century-scale projections has enabled a broader set of applications, including enhancing productivity in weather-sensitive industries, managing weather risk, protecting life and property, and negotiating international treaties.

Public, private, and academic sectors have all played important roles in the extension. Much of the innovation for individual industry and economic sector use has been developed in the private sector. The academic community continues to improve understanding of climate variability and predictability through its research. The public sector has improved the accessibility of its data and information, including the output from the extensive forecast models now being run. Further, the scientific and user communities are increasingly articulating the improvements required in climate services to enable improvements in decision making.

EVOLUTION OF CLIMATE SERVICES IN THE UNITED STATES

CONTEXT

The provision of climate services in the United States is continually evolving in response to a growing understanding of climate, from the scales of natural variability to long-term climate change, combined with a growing appreciation of the intersection of climate and human endeavors. The context for this evolution is best viewed by starting with a brief historical review and then looking at the present National Weather Service; the state climatologist program; nascent ocean observing, modeling, and predicting endeavors; and other federal, state, and local activities, with a vision of a more comprehensive "environmental service". This context arises because "climate service" can be considered as a (thoughtfully) structured portion of a larger applied earth sciences program with a greater degree of organization, purpose, and continuity that is likely to result in substantially greater national benefit. The weather service began with a system that was based largely on observations and, as capabilities increased and demands for service were more clearly articulated, expanded to a predictive service. Climate services have an analogous evolution, with an observation-based historical emphasis followed by a growing emphasis on abilities to forecast seasonal to decadal changes. While it is analogous to a weather service in that sense, it is important also to acknowledge the major differences.
ROLE OF GOVERNMENT AGENCIES: A BIT OF HISTORY

Changnon (1995) describes one of the earliest applications of climate data as the use of weather observations in colonial times to plan agriculture and construction. The U.S. Weather Bureau, founded in 1870, established the Weather Records Center, later to be called the National Climatic Data Center (NCDC) in 1951. The name was a clear indication of the concept of climate information in the 1950s. The next major evolution in the provision of climate services was the Weather Bureau's creation of the state climatologist program in 1954 (Hecht 1984). The program was an attempt to better link the needs of state and local users and the capabilities of the Weather Bureau. The program was successful in some states and not particularly successful in others. Because of budget pressures, uneven results, and increasing concerns over excessive federal involvement in what was perceived to be a state role, the program was terminated in 1973, and states were left to determine what kind of state climatologist program, if any, would be supported. The present situation is also mixed. The current president of the American Association of State Climatologists divided the state programs (including that of Puerto Rico) into four categories. Seven states have what he defined as good programs, 19 have satisfactory programs that are good but limited by funding, 21 are marginal, and 4 have no program at all (Angel 2000). One noteworthy example of a successful state program is the Oklahoma Climatological Survey (OCS) (see Box 2–1). Such successes provide important lessons for extracting "best practices" for efforts to move toward more effective climate services in the United States.

to promote the understanding of climate and the provision of climate services. The act directed the development of a network of regional climate centers (RCCs) to meet regional climate service needs (Hecht 1984). The centers were established over the ten-year period 1981–90. The executive branch, however, never embraced the concept of the RCCs because they were all created by congressional earmarks and add-ons; the Department of Commerce proposed their elimination each year, and Congress restored them in each appropriations cycle. Six RCCs currently exist and report to NCDC, which also maintains close ties to the state climatologists. The Western Regional Climate Center processed 35,000–40,000 requests from 1982 to 1995, and the demand is increasing. The center's characterization of the requests demonstrates interest in a broad array of topics, such as agriculture, engineering, legal issues, and economic development (see Appendix D).

The RCCs' focus is to apply climate information to regional issues, recognizing the "regionality" of the issues facing decision makers. The centers emphasize the breadth of climate service requirements, including evaluation of data, archiving, indexing, retrieval, quality assessment, synthesis, interpretation, and dissemination, and maintain a central focus on the user (Redmond 2000). A major climate product of the RCCs, and one not available at NCDC or most state climate offices, is on-line access to daily updated climate conditions, including the temperature and precipitation conditions of yesterday (or the last few days) and interpretations of how those conditions rate climatologically against values from the past 50–100 years. That type of information is often sought by those attempting to rate what has just occurred against past behavior and past decisions. For example, government decision makers often seek such information to get a rating on recent extremes, such as a recent two-day rain-storm that produced flooding in southern Wisconsin. Regional centers identify a key problem in providing climate services—that is, climate services are made up of a mixture of elements or components without effective national integration. The National Oceanic and Atmospheric Administration (NOAA) has been unsuccessful in its attempts to link the activities of NCDC, the RCCs, and the state climatologists.

The Climate Analysis Center, established in response to the National Climate Program Act, is a part of the National Weather Service's (NWS) National Centers for Environmental Prediction. When first established, it included a diagnostics component, a data and information component, and a prediction component. The climate diagnostics component received considerable attention after the 1982–83 El Niño. With the rapid scientific advances

in the understanding of the El Niño/Southern Oscillation that took place in the 1980s and early 1990s, the center's name was changed to the Climate Prediction Center (CPC). Recognizing that a major service now provided by the CPC is the seasonal to interannual forecasts issued for the United States, the NWS recently created a Climate Services Division within its headquarters to provide oversight and direction of the CPC.

The climate activities within NOAA now consist of the CPC within the NWS, NCDC within the National Environmental Satellite, Data, and Information Service, and several research laboratories⁷ within NOAA's Office of Research.

The National Aeronautics and Space Administration's (NASA) mission includes efforts to support the development of new and innovative observations, research, modeling, and data and information management that have a direct impact on the potential to provide climate services. NASA and NOAA provide satellite and in situ observations that are the backbone of the climate observing system. Mechanisms for establishing sustained long-term climate satellite and in situ observations, which are viewed by the Board on Atmospheric Sciences and Climate (BASC) as essential to supporting a wide variety of climate services, are yet to be realized (see NRC 2000b, 2000c). NASA has also developed an applications program to create public-private partnerships that result in the use of NASA science and technology to improve environmental, community growth, resource management, and disaster management decisions. The NOAA and NASA efforts to combine forecasts and observations through data assimilation and reanalysis are providing an invaluable best estimate of a host of weather and climate variables that are difficult to measure. This reanalysis using state-of-theart models is rapidly becoming the de facto climate record.

A number of the agencies participating in the U.S. Global Change Research Program8 (USGCRP) contribute to the development of climate services through data collection and/or efforts to improve climate prediction capa

bilities. For example, the U.S. Department of Energy maintains a series of research observation sites that contribute to the understanding of climate processes. It has also supported climate modeling development through its carbon dioxide research programs. The National Science Foundation has provided support for improved climate model parameterizations and increased understanding of natural variability such as ENSO. The U.S. Environmental Protection Agency has a growing effort to link climate change with the assessment of impacts on water, including water quality, and human health and a continuing interest in maintaining observation capabilities to assess environmental standards for air and water. The U.S. Geological Survey (USGS) and some states maintain hydrologic measurement stations across the nation. Many USGS gauging stations are supported by joint federal-state funding. The U.S. Department of Agriculture (USDA) maintains a Joint Agricultural Weather Facility that relates crop production to weather and climate events; this facility is staffed jointly by the USDA and the NWS (USGCRP 2000).

The nation has also provided substantial support to increase the ability to model climate variability and climate change through a commitment to fund national centers, including the National Center for Atmospheric Research, the NOAA Geophysical Fluid Dynamics Laboratory, and the NASA Goddard Institute for Space Studies. Such efforts are critical in providing climate services for national assessments of climate impacts, for participating in such international assessment activities as the Intergovernmental Panel on Climate Change (IPCC), and in considering U.S. participation in international treaties. However, those institutions were designed as research centers, not as service centers. In addition, the United States has provided support for such innovative institutions as the International Research Institute (IRI), whose mission is to show that forecasts on seasonal to interannual time scales can be used successfully in real and meaningful applications.

Many of the research aspects of the various agency programs are coordinated through the USGCRP and are reported annually to the nation through the publication of *Our Changing Planet* (see, e.g., USGCRP 2000). However, there is no comparable mechanism for promoting or coordinating the climate services aspects of the various agencies.

DEVELOPMENT OF THE PRIVATE SECTOR

After World War II, thousands of meteorologists who had been trained for the war effort returned to the United States. Many went back to their previous

employment; some went into the U.S. Weather Bureau and academic institutions; but several formed private weather forecasting services and began applying the skills they honed in wartime. The latter and their companies responded to the needs of weather-sensitive businesses and industries for weather and climate information that was more tailored to their specific needs than what could be provided by the Weather Bureau.

In 1957, the American Meteorological Society, recognizing the need for a professional certification process, initiated the Certified Consulting Meteorologist (CCM) program. The growing need for specialized weather- and climate-related services has resulted in substantial growth in the environmental consulting industry and in the demand for trained meteorologists. There are currently over 550 CCMs.

At present there are over 250 private weather firms listed on the NWS Web site (<http://www.nws.noaa.gov/im/more.htm>), and most offer climate services as part of their product suite.

A POSSIBLE FUTURE

For the last 60 years the United States has developed and supported a national weather service that today uses vast amounts of meteorological data, assimilates these data into models of the atmosphere, and produces and disseminates about 24,000 weather forecasts each day (Hooke and Pielke 2000). At the beginning of the twenty-first century, two changes are occurring. First, growth in knowledge is enabling recognition of the interactions of a multitude of environmental stresses, including land-use change, climate variability and change, waste products, population growth, and health and well-being. Second, technological advances in earth observing sensors and systems, in computers and information storage, and in communication networks are enabling a much more comprehensive approach to environmental conditions. Combined, those two factors provide the nation with the potential to transform a weather service with an inherently short-term perspective into a decision-centric environment service that spans the spatial scales of local to global concerns and the temporal scales of minutes to a century, including both weather and climate (NRC 1999c).

Aided by that technological evolution, a broader, organized, and sustained environment service will probably emerge as the needs of decision makers become more complex. In addition, the environmental approach should reflect the fact that most regions are influenced by multiple stresses, such as weather

and climate, land-use change, and input and character of pollutants. *Our Common Journey: A Transition Toward Sustainability* (NRC 1999c) recommends moving toward a research framework that looks at all elements that influence a specific locale or region (multiple stresses). An environmental service will likely develop as this more holistic place-based approach to earth sciences is undertaken. Such an approach was also recommended in *Grand Challenges in the Environmental Sciences* (NRC 2001c) and *The Science of Regional and Global Change: Putting Knowledge to Work* (NRC 2001b). In this view, climate service is an important ingredient in a service that will ultimately support integrated management. It is a logical and needed next step.

The climate services under discussion in this report would use observations of the physical, chemical, biological, and geological state of the solid earth and its surface cover, the ocean, and the atmosphere extending from the earth's surface to outer space. The observations would include the meteorological, hydrologic, oceanographic, atmospheric, and space observations currently made. Central to the scope of climate services is the need for them to embrace wide ranges of time and space scales. This is an expansion of what the NWS uses as a data base and predictive framework, but it is not as comprehensive as an environment service, in which the data and predictive models would include, for example, species populations and distributions, and the data systems would be modified to provide the accuracy and stability necessary for climate.

In many ways, the evolution of technology and growth in knowledge have enabled the establishment of a climate service and will continue to foster the evolution of a climate service to an environment service. Data storage and exchange have been made possible. Computational resources suitable for such an endeavor are within reach. Many of the global observing capabilities are now online in the ocean, as well as on land and in space. Increasingly, global and regional atmospheric and oceanic models are moving toward understanding the variability and predictability of the fluid envelope of the earth system, including its biogeochemical, hydrologic, and ecosystem elements. Those capabilities are reflected in the scope of the climate service in this discussion. The present emphasis on assessments at global to regional scales sets the stage for this new climate service. The NWS, the IRI, the IPCC, the U.S. Assessment, the RCCs, and the state climatologists can be viewed as prototypical, and such activities are likely to evolve in response to the demand for climate information. However, BASC concluded that a more cohesive management and integration will result in a comprehensive climate service that

is capable of integrating and synthesizing data from diverse sources and is willing to accept the charge to do so, rather than a diverse set of services for different elements of the earth system. The climate service should be inherently integrative and synthetic, capable of bringing together diverse data sets and advancing the ability to understand and predict climate variability and change. It should produce products and achieve the benefits of access to global data and global participation.

3

GUIDING PRINCIPLES FOR CLIMATE SERVICES

Climate services, by definition, are mission-oriented and driven by societal needs to enhance economic vitality, maintain and improve environmental quality, limit and decrease threats to life and property, and strengthen fundamental understanding of the earth. At an August 2000 workshop, the Board on Atmospheric Sciences and Climate (BASC) reviewed the various climate service activities described in the previous chapters. Representatives of the various activities (the state climatologists' programs, the regional climate centers, the National Climatic Data Center, the Climate Prediction Center, private sector organizations, etc.) were asked to discuss not only their activities, but also those characteristics that make their activities successful or present difficulties. The discussion led to the identification of best practices that are suitable for an overall climate service for the nation. Those best practices were then distilled into five guiding principles and are set forth below. The principles were developed through an assessment of current climate service activities and substantial experience within the atmospheric sciences in the development of weather services.

THE FIVE MAJOR GUIDING PRINCIPLES

1. The activities and elements of a climate service should be usercentric. The interface between the knowledge base and the user is critical if

the objective is the timely production and delivery of climate information relevant to the user's decision needs. "Climate forecasts are useful only to the extent that they provide information that people can use to improve their outcomes beyond what they would otherwise have been." That statement, from *Making Climate Forecasts Matter* (NRC 1999a), is part of a series of findings that describe the importance of the interface between users and data providers. The report and climate services examples cited earlier are the basis of a set of requirements for a user-centric climate service:

- A comprehensive service should strive to meet the needs of a user community at least as diverse and complex as the climate system itself, ranging from the international community to individual users and involving both the public and private sectors. Central to the scope of a climate service is the need to embrace wide ranges of time and space scales because decision making occurs on all scales from local to global and from weeks to centuries.
- Users will become increasingly diverse, knowledgeable, and specialized. Consequently, their needs will evolve. Greater education of users in the meaning and significance of climate information is likely to promote greater use and more robust application of the information.
- The key to an effective climate services program is a vigorous, cost-effective, and comprehensive intersection of knowledge and its use. Therefore, the following elements are essential for a successful program:
- Mutual information exchange and feedback.
- Communication and accessibility of information.
- Continuing evaluation and assessment, by users and providers, of the use and effectiveness of the services.
- **2. If a climate service function is to improve and succeed, it should be supported by active research.** The ability to serve national climate needs is a direct product of the U.S. investment in the pursuit of new and useful knowledge. A continuous and concerted effort to develop and incorporate new knowledge is a requirement of any sustainable service.
	- Research should focus on improved understanding of the dynamics of the diffusion of knowledge and information, including how it is transferred, communicated, and used and the implications of its use.
	- Climate services should be an objective of mission-oriented research.
	- Active mechanisms should be employed to enable the transition from research discovery to useful products (NRC 2000a).

- **3. Advanced information (including predictions) on a variety of space and time scales, in the context of historical experience, is required to serve national needs.** The case studies in Chapter 1 describing the current demand for climate services illustrate the scope of the knowledge base that should be included to serve national needs. The knowledge base should include the following:
	- Continuous, accurate, and reliable historical climate observations at diverse locales. Many applications use time series of climate variables to estimate trends, departures from average conditions, and extremes (low-probability events).
	- Access to climate observations that include the perspective of the paleoclimatic record where available and appropriate to guide understanding of natural variability.
	- Forecasts and outlooks, from a month to a year in advance, including an analysis of probabilities, limitations, and uncertainties and mission-oriented specialized products, which are of major importance to a large segment of the user community. Understanding the skill of such products is critical for their effective and beneficial use.
	- Access to the growing knowledge base on the causes and character of natural variability on time scales of seasons to decades.
	- Long-term climate simulations, starting from the beginning of the last century when the robust historical record begins and extending to the next 100 years. Such simulations provide an important service to the nation when coupled with an analysis of limitations and uncertainties.
	- Information on spatial scales ranging from local to regional to global.
- **4. The climate services knowledge base requires active** stewardship. The quality, consistency, accessibility, and documentation (including limitations and uncertainties) of climate information are a ubiquitous concern of current users and help to define requirements for stewardship of the nation's climate information:
	- Open and free exchange of data is essential to incorporate the interdependence and teleconnectivity of elements of the global earth system and to consider the full strategic interests of the United States as part of the global economy.
	- Reliable long-term observations and data archives are of critical importance (see Box 3–1).

- Emphasis on converting observations into useful records is essential. Multi-purpose observations, including in situ and space-based systems, and an array of technologies and variables have proved to be the most useful for the characterization of climate.
- The most successful climate observing systems have included synergism among observations, theory, and modeling.
- Development and maintenance of a robust and easily accessible delivery system are necessary for an effective climate service.

The criteria presented in this report are consistent

with the analysis therein. This long history helps to define the roles of the participants in the delivery of climate services:

- The role of all government agencies should be motivated by the concept of "public goods and services." Those are goods and services that are *non-rival* and *non-exclusive.* The following premises should guide these activities:
- Tax dollars should not subsidize activities of individuals or individual commercial operations.
- The government has responsibility for managing issues that are clearly in the wider public interest, including protection of life and property, increasing understanding of climate and weather, and improving services through basic and applied research.
- The government has international responsibilities for implementing and coordinating programs on behalf of the public.
- The government should be responsible for maintaining the nation's official climate records.
- The role of the private sector is motivated by and acts under market forces and owes principal responsibilities to its own and its clients' interests. This defines substantially different premises:
- The private sector generates data and products to which it may retain a proprietary interest, even if the data are subsequently transferred to a public agency unless otherwise agreed upon.
- The private sector may maintain the confidentiality of its dealings with its clients and hence of the content and character of the information it provides to its clients (subject to any applicable legal actions or restrictions).
- The private sector has substantial freedom in determining the conditions (restricted or unrestricted) for providing its valueadded data and services to the public, academe, or government agencies.
- The private sector engages in basic and applied climate research to meet the needs of its users, concentrating on user-centric products and services.
- Members of the private sector constitute a principal resource for the innovation, development, and manufacture of advanced technological devices and equipment for making climatological observations, for computing, and for telecommunications.
- Academic research organizations play a critical role in climate education and research. These activities are focused primarily on the following:

- Traditional university roles of research, education, and outreach, much of which may be funded by federal research and development agencies and state governments.
- Research, data compilation and analysis, and product development, sometimes administered as part of a hybrid academic /government culture (e.g., the National Center for Atmospheric Research, the National Oceanic and Atmospheric Administration/University Cooperative Research Institutes, and offices of state climatologists).
- Research, data compilation and analysis, and product development in partnership with industry (including technology commercialization) that also fulfill the research, education, and outreach mission of academe.

BASC provides these principles for consideration in future climate service organizations, whether they are entirely new organizations or a refocusing or realigning of existing organizations. BASC believes that these best practices, if applied universally, could improve the provision of climate services to the nation.

4

FIRST STEPS TOWARD AN EFFECTIVE CLIMATE SERVICE

The scope and importance of climate services in the United States is growing. That growth is a logical result of increased capabilities to monitor, understand, and predict climate variations; increased concern about the potential for future climate change; and increased awareness of the value of climate information. Climate information is and will be used in many diverse ways to support decision making, and a climate service should reflect this diversity. Its scope, therefore, should be defined by the temporal and spatial scales that make climate information useful.

The value of weather information is in its timeliness, so its value decreases quickly with age. In contrast, a substantial number of the climate-related user requests described in this report are based on the analysis of time series of variables to estimate trends, departures from average conditions, and extreme conditions (low-probability events). Climate services have a product orientation that extends from weekly to centennial time scales. Therefore, the value of climate observations tends to increase with accuracy, consistency, and continuity over time. However, the sampling interval must be short (e.g., to capture diurnal variability) to create an accurate statistical basis for analysis of both short-term extremes and long-term trends. Accurate knowledge of weather-scale variability is essential for producing climate products. Historical records add context to the understanding of variability. The scope of the supporting modeling endeavors should be equally comprehensive. Models become in

creasingly valuable if they add value to the observational base, correctly anticipate departures from the norm a season or a year in advance, or help to define either risk or opportunity tied to longer-term trends. Therefore, the scope of the modeling efforts should include the use of model-data hybrids to create long-term climatologies of variables that are not directly observed, a combination of statistical and dynamical models to assess conditions a season to a year in advance, and coupled earth-system models designed to incorporate changes in the factors (e.g., greenhouse gases, aerosols, solar variations, and land-cover change) that force long-term changes to the climate system (NRC 1998b, 1999b).

The range of spatial scales is equally diverse. Climate variability can have small spatial scales, and many climate products will be place-based (specific to one site). Hence, high resolution becomes a critical need in data used in creating site-specific products and in developing gridded products to guide decisions. Where inputs and products cannot be portrayed on common high-resolution grids, the ability to use models to downscale information is required to provide the requisite high-resolution products. Although many problems are site specific, the generation of climate products will rely on data not only across disciplines and time but also across space to points distant from the place of interest. For example, a regional seasonal forecast of precipitation and temperature in the United States will rely on ocean observations and surface marine observations, as well as on soil moisture, to initialize the global coupled ocean—atmosphere land model used to produce the forecast. At the same time, downscaling of the forecast requires local climatologies, statistics, topography, land-use data, and other local or regional information.

As the decisions vary over space and time, climate services should at once be responsive on the local level and integrative of all the wide-ranging and diverse influences on that place. Fundamental to the development of climate information that serves the needs of the nation is a commitment to a global observing system (NRC 1999b); recognition of the importance of place-based, local and regional observations; a strong service-oriented modeling capability (NRC 1999c; 2001a); and a commitment to a user-centric focus (NRC 1999a).

The observing system required for the climate services is global. At the same time, the place-based studies of climate impacts will often require a higher resolution of observations. Therefore, attention to the various national and regional networks is also required. In response to changing capabilities and needs, the infrastructure of climate services cannot be seen as static. An important aspect will be the design and optimization of the observing system. That

should be undertaken through the interplay of models and observations and requires validation of models (comparison with observations) and user feedback. Although the synthesis of observations by assimilation into models cannot replace the need for a comprehensive suite of observations, the design of the observing system should be undertaken in the context of ever-improving models. Thus, observing system simulation experiments that can guide technological advances for observations will be an important component of climate services (NRC 2000a).

It is also essential that the United States be engaged in, through its climate service, the free and open exchange of data and products and that it benefit from the participation of non-U.S. scientists (NRC 1995). Climate variability increasingly points to the interdependence and teleconnectivity of elements of the earth system on a global basis. The economic well-being of other countries is often in the strategic interest of the United States; hence, national interests to be served by a climate service should be broadly defined (NRC 2000a).

The temporal (time scale) scope of observations, forecasts, and projections mandates on the one hand that climate services be closely linked to the present activities of weather services and on the other hand that it develop a capacity to support IPCC-type assessments routinely. One important challenge of initiating a climate service involves understanding the nature of the climate assessment process, defining and institutionalizing the active role that a service should play in the process, and building in the flexible, ever-changing interfaces that should be maintained among the multiple players who will perform along the pathway from data to decision. The process of adaptive learning (or the integration of learning and action) in this enterprise should be anticipated in the institutional setting used and should be expected to continue indefinitely. Because the service will be defined in large part as a decision-support system, it is important that it be developed by focusing on a broad suite of practical problems that will illuminate the breadth and character of stakeholders. Among the products of the climate service should be those that quantify the uncertainties in climate forecasts and analyses. The service should make clear to users the sensitivity of the products to the data and methods used in preparing them. Such products, ongoing selfevaluation within the climate service, and user feedback will be important in guiding the evolution of the climate service (NRC 1999a).

The following recommendations are constructed around a strategy that is based on enhancing the capabilities of existing institutions and agencies and building a stronger climate services function within this context. Therefore, the

objective is to define the first steps that can be taken immediately to enhance the effectiveness and efficiency of U.S. climate services. These first steps are designed to promote climate services that are user-centric, that reflect the value of both statistical and predictive climate knowledge, and that promote active stewardship of climate information. The Board on Atmospheric Sciences and Climate (BASC) did not assign explicit priorities to the recommendations, but lower-numbered recommendations generally are more important than highernumbered recommendations in the same section. Taking these first steps will pay large dividends at relatively modest cost because several of the elements that are needed for climate services already exist. In addition, such recent advances in technologies as the Internet, data storage, and computing make possible economies that could not have been realized even a few years ago.

1. PROMOTE MORE EFFECTIVE USE OF THE NATION'S WEATHER AND CLIMATE OBSERVATION SYSTEMS.

Recommendation 1.1: Inventory existing observing systems and data holdings. The climate observing system is the backbone of any climate service. A fully integrated observing system that supports climate services, either for climate prediction or the provision of regionally tailored climate products, does not currently exist. No agency currently has responsibility for carrying out or coordinating a comprehensive program of climate observations (NRC 1998d). The National Research Council report (2001b) *The Science of Regional and Global Change: Putting Knowledge to Work* summarizes this key issue: "The observing 'system' available today is a composite of observations that do not provide the information needed nor the continuity of the data to support decisions on many critical observations." A number of federal agencies, including the National Oceanic and Atmospheric Administration (NOAA), the Department of Agriculture (USDA), the National Aeronautics and Space Administration (NASA), the Department of Energy (DOE), the Federal Aviation Administration (FAA), and the Department of the Interior (DOI), operate observing systems that could be components of a fully integrated climate observing system. A first step in such an integration is an inventory of existing observing systems, their data holdings, and their management rules. BASC could find no evidence of such a basic inventory of observations and their management. Therefore, the board recommends that each agency identify its climate-related observing systems and data holdings. The inventory should include information identifying the following: (1) what purpose each set of

observations and data serves for the provision of climate services, (2) how each observing system addresses user needs, (3) how each system is managed, and (4) what considerations govern decisions regarding the observing systems.

The National Research Council report (1998a) *The Atmospheric Sciences Entering the Twenty-First Century* suggests that "the Federal Coordinator for Meteorological Services and Supporting Research should lead a thorough examination of the issues that arise as the national system for providing atmospheric information becomes more distributed." Following that statement and in consideration of the role of the federal coordinator, BASC suggests that the Office of the Federal Coordinator for Meteorology⁹ (OFCM) be considered as an agent for this recommendation. To the extent practicable, the OFCM should include a survey of private or publicly funded but privately operated research programs or operational climate facilities. Additionally, each should be evaluated for adherence to the ten principles of climate observations (see Box $3-1$), and estimates should be made of the resources necessary to bring them into full compliance. Initiatives for acquiring the resources should be a high priority in the budget process.

Recommendation 1.2: Promote efficiency by seeking out opportunities to combine the efforts of existing observation networks to serve multiple purposes in a more cost-effective manner. "Full interagency leadership is needed to create a cost-effective and balanced observing system" (NRC 1998a). The current multi-agency approach creates problems with both balance and effectiveness. For example, the current observational approach creates gaps because there is no long-term framework or funding for building integrated, sustained, end-to-end capability (NRC 2001b). That problem is evident in the number of cases in which the observational approach relies on capturing opportunistic measurements from research programs. Furthermore, observations that are currently made by many agencies are often driven solely by an agency's focused mandate, without consideration of low- or no-cost steps that could be taken to make the data more useful to a broader array of users

(NRC 2001b). The inventory of existing observing systems recommended above is the first step in creating a more efficient system.

The second step should be a deliberate effort to promote efficiency and balance. BASC recommends (1) examining the systems for redundancy and determining the merit of the redundancy, (2) examining potential synergisms between systems whereby co-location, co-management, or joint planning for future improvements would improve the knowledge base and/or save substantial costs, and (3) examining systems for gaps and weaknesses (including how data are managed) that could be addressed through more efficient operations or management. Following Recommendation 1.1, that seems to be an appropriate activity for the OFCM.

This recommendation reflects numerous examples of potential synergism between local, state, and regional networks, many of which have been set up to serve specific needs and are managed as such. For example,

- The 700-station USDA SNOTEL (Snow Telemetry) network is designed to furnish hydrologic and temperature information from mountainous locations in support of water supply forecasting for the western states. It is the only extant large-scale high altitude network in the nation (or the world) and could supply valuable information on climate variability and climate change in mountainous regions (the source of most of the West's streamflow) and greatly assist with regional reanalysis.
- The 15-year-old Remote Automatic Weather Station (RAWS) network is managed by DOI's Bureau of Land Management and USDA's Forest Service (and other agencies). The network records hourly meteorological data from 830–930 stations (depending on the season) throughout the western states. This data set is downloaded via satellite to the National Interagency Fire Center in Boise, Idaho, and immediately transferred for archival at the Western Regional Climate Center in Reno, Nevada. Originally oriented toward fire management, the network has increasingly important applications in natural resources management throughout the public lands of the West.
- Over the past decade, the FAA has installed over 1,000 automated observing systems at airports across the country. These systems, which are designed to provide aviation weather information, could contribute to improved climatologies of wind and temperature. Suitable upgrades to achieve the ten principles listed in Box 3–1 would increase the utility of these networks to serve the climate community without requiring the establishment of a new and expensive supporting infrastructure. Similar enhancements to other networks could lead to similar results. Workshops should be convened to

examine the issues involved in making such networks more efficient and to recommend priorities for such upgrades. Participants would include managers and providers of the networks and their data sets and potential customers for such information, from both the public and private sectors. A state-by-state analysis of all observational networks should be performed to analyze the suitability of existing networks in providing useful climate data and to consider possible upgrades. Data base links to a centralized climate service should be encouraged.

This process could be used to integrate the existing observational capability and to determine the adequacy of existing networks, the potential for their augmentation, and the gaps that remain in the climate observations. An option for addressing the gaps is proposed in Recommendation 1.5.

Recommendation 1.3: Create user-centric functions within agencies. An evaluation of the performance of the federal government in the 1997–98 El Niño identified the lack of clearly delineated agency or interagency functions designed to evaluate user demand and needs continuously, to create feedback that improves climate services through the interaction of users and producers, and to create new capabilities and functionalities that serve the needs of decision makers (Changnon 2000). That is but one example of the importance of the interface between the knowledge base and the user if the objectives are the timely production and delivery of climate information relevant to the decision needs of the user. The NRC (1999a) report *Making Climate Forecasts Matter* provides guidance on the nature of the interface: "Participatory approaches to delivering climate information might include structured dialogues between climate scientists and forecast users to identify the climate parameters of particular importance to users and the organizations that users might rely on for climate forecast information…. They would tend to make forecast information more decision relevant, to improve mutual understanding between scientists and forecast users, and to encourage appropriate interpretation and use of forecast information." In addition, the report argues for systematic efforts to bring scientific outputs and user needs together to increase the utility of forecasts (NRC 1999a).

The above reports, combined with the review of current and potential climate services by BASC, yielded the first guiding principle for climate services (see Chapter 3)—that is, the activities and elements of a climate service should be user-centric. Three elements, given in Chapter 3, are essential for a vigorous, cost-effective, and comprehensive intersection of knowledge and its use:

(1) mutual information exchange and feedback, (2) communication and accessibility of information; and (3) a continuing evaluation and assessment, by users and providers, of the use and effectiveness of the services. Those three essential elements are unlikely to occur if there are not user-centric functions within agencies. There must be formal mechanisms that support and enable usercentric design and improvement. BASC recognizes that this is not a simple task. There can be a strong cultural and linguistic gap between the climate researcher and the user. Effective involvement of the user community is essential.

Recommendation 1.4: Perform user-oriented experiments. A partnership of providers and users should be empowered to propose and execute experiments designed to promote and assess the use of climate information. The effectiveness of information depends strongly on the systems that distribute it, the channels of distribution, recipients' modes of understanding and judgment about the information sources, and the ways in which the information is presented (NRC 1999a). The research base for examining the effectiveness of information distribution and the value of climate information and forecasts through research on actual data use is thin (NRC 1999a).

The development of a comprehensive research program to examine the benefits and dissemination of climate information is outside the scope of this report. However, BASC found considerable uncertainty associated with the types and value of products that should be provided by different agencies as part of a climate service. A first step to addressing this concern is the design of experiments that would permit a rapid assessment of users' needs, wants, and preferences at low cost. For example, to test and demonstrate the utility and user acceptability of climate information data furnished in a real-time Web-based environment, the federal government could fund the user access charges for an already existing climate data network (s) , allowing the user community free access to the data stream. That would provide the managing agencies with an almost instant statistical compilation of the user activities that include such elements as the number of users and the number and context of user accesses. Typical data sets to be considered might be the Oklahoma Climatological Survey Mesoscale Network, SNOTEL, and SCAN (Surface Condition Analyzer).

Recommendation 1.5: Create incentives to develop and promote observation systems that serve the nation. Currently across the nation there

is a wide disparity in efforts to establish local-level weather and climate networks that augment stations run by federal agencies and that are established to aid local and state decision making. A substantial new program to coordinate and manage the nation's observing systems is probably unlikely in the near future, given the multiplicity of agencies and missions involved in collecting and disseminating information. However, initial steps that promote greater coordination; active stewardship involving quality, consistency, accessibility, and documentation of climate information; and open and free exchange of information will enhance our ability to serve the nation. After the results of implementing Recommendations 1.1 and 1.2 are assessed, additional observing capability might still be required. With this objective in mind, BASC examined best practices associated with current climate service functions. Oklahoma's mesoscale network is an example of an extensive network that helps the state to provide its citizens with a wide array of climatological services, such as public safety in the face of severe weather, assessment of drought, recommendations for weather- and climaterelated agricultural management (e.g., spraying), and fire danger assessment. Other states have less extensive networks, such as Nebraska's Automated Weather Data Network (see <http://hpccsun.unl.edu/awdn/home.html> for a more comprehensive discussion of local networks), or no established network at all beyond the federal sites of the FAA or the National Weather Service (e.g., Pennsylvania).

A federal matching program for states and regional centers should be initiated to develop observation systems that obey the ten principles (in Box 3– 1), promote free access, and create strong partnerships with users. Part of a set of initial steps that could be taken to establish a more comprehensive national climate network is the establishment of state or regional networks. Related local climate services should also be encouraged. One possible mechanism would be for the federal government to establish a matching program for states and/or regional climate centers to develop a climate observing network. The advantages of such a program are that it would be relatively inexpensive; it would enhance the value of the observations by following basic guidelines for accuracy, consistency, metadata, etc.; and it would allow the data network to be tailored to local climate problems.

2. IMPROVE THE CAPABILITY TO SERVE THE CLIMATE INFORMATION NEEDS OF THE NATION.

The science and understanding of global and regional climate have gone well beyond a statistical analysis of historical records under the assumption of

climate stationarity. Forecasts of seasonal to interannual climate variations and long-term climate projections have become part of the breadth of climate service products. In many cases, the types and nature of the forecast or prediction products that should be provided through a climate service require additional efforts that promote a transition from research to operational efforts and new investments in modeling and modeling infrastructure. The recommendations in this section are derived from several recent National Research Council reports that outline needs for improvements in the climate observational and forecasting systems and for effective planning of the transition from research to operations. The recommendations given here use the findings of those reports as a means of emphasizing critical contributions and needs for improved climate services.

Recommendation 2.1: Ensure a strong and healthy transition of U.S. research accomplishments into predictive capabilities that serve the nation. The United States has a strong atmospheric and oceanic research community. This investment in the pursuit of new and useful knowledge has the potential to enhance our ability to serve national climate needs. In many ways, the research effort represents a significant body of new and useful products for a variety of decision makers. However, there is a need to enhance the delivery of products useful to society that stem from this investment in research. Many of the most important aspects of this enhancement are described in the report *From Research to Operations in Weather Satellites and Numerical Weather Prediction: Crossing the Valley of Death* (NRC 2000a). Additional discussions of climate-related transition issues are discussed in *Issues in the Integration of Research and Operational Satellite Systems for Climate Research, Parts I and II* (NRC 2000b, 2000c). The key elements include implementing development, testing, and integration capabilities to incorporate observations and advances in understanding into predictive models; providing adequate staffing for operational missions; providing a continuing process for assessing technology and updating it as needed to accomplish the mission; creating stronger collaborative efforts in the development of community prediction models; and institutionalizing the transition process from research to operations. Many of those recommendations were addressed to the Environmental Modeling Center at NOAA and operational sensor/satellite development between NASA and NOAA, but the basic themes can be easily transferred to other observation and predictive modeling efforts.

Recommendation 2.2: Expand the breadth and quality of climate products through the development of new instrumentation and technology. BASC's twenty-first century report (NRC 1998a) included two imperatives. The first was to develop a specific plan for optimizing global observations by taking into account the requirements for weather, climate, and air quality and for the information needed to improve predictive models. The second sought a commitment for developing new capabilities for observing critical variables, including water in all its phases, wind, aerosols, and chemical constituents. The twenty-first century report specifically notes the importance of a series of emerging issues (climate and health, management of water resources, and emissions of pollutants into the atmosphere) to the atmospheric sciences. A focus on those emerging topics increases the value of atmospheric information to society. Chapter 3 states that "A comprehensive service should strive to meet the needs of a user community at least as diverse and complex as the climate system itself." To support new modeling and analysis capabilities and to support and improve the existing climate database, it is necessary to continue to improve existing sensors and their instrumentation and to develop new ones. The key is to examine the new instrumentation and technology in terms of the expected expansion of the products and services (NRC 1998a; 1999d) and to develop capabilities that address their production in service to the nation. Air quality and hydrologic products are logical first investments. The types of specialized sensors that should be developed include some for measuring (1) air pollutants in order to couple weather, climate, and air quality and (2) soil moisture, radiation, elements of land use, and boundary-layer profiles of temperature, humidity, and wind on regional and subregional scales to better predict surface hydrology and moisture conditions.

The new instruments should obey the ten principles listed in Box 3–1 for climate observations that were adopted by BASC as part of the guiding principles for climate services. New technologies should have at least the same capabilities as the old, they should not be a burden on the research enterprise, and clear transition modes to operational use should be established (NRC 2000a).

Recommendation 2.3: Address climate service product needs derived from long-term projections through an increase in the nation's modeling and analysis capabilities. Climate modeling and analysis are the foundation for developing climate scenarios for the future. In turn, the scenarios are inputs for national and international decisions on potential adapta

tion and mitigation efforts. The U.S. National Assessment of Climate Change Impacts on the United States calls for a stronger capability for providing such climate information. The nation's climate modeling expertise is widely recognized as the best in the world, and this expertise is dedicated to developing state-of-the-science model capability. However, these research enterprises currently do not provide the ensembles of long-term simulations, extending from the start of the robust historical record to at least the next 100 years, that are required to serve national and international assessments. The Assessment states that "the demand for these climate services exceeds the capabilities of the research functions of the nation's climate modeling centers." In fact, the U.S. Assessment used Canadian and United Kingdom model products to examine the impacts of climate on the United States. Furthermore, the current U.S. National Assessment of Climate Change Impacts demonstrates a demand for a host of specialized climate products that tie future climate projections more directly to specific decisions or vulnerabilities. The assessment process requires greater access to and greater understanding of the limitations inherent in future projections to weigh the advantages and risks associated with alternative courses of action. An important requirement is the development of scenarios for the evolution of the factors that force climate (e.g., aerosols and greenhouse gases). Coupled system models, operating at substantially finer resolution, are required to link climate with the scales of human decisions. The nation's modeling and analysis centers need to develop the capabilities to provide long-term simulations, analysis of model limitations and uncertainties, and specialized products for impact studies (NRC 1998b, 2001a).

Recommendation 2.4: Develop better climate service products based on ensemble climate simulations. There is a need for ensemble seasonal to interannual forecasts and climate simulations that can be devoted to studies of climate impacts, vulnerabilities, and responses. The nation is scientifically capable of providing these products; however, it will require dedicated resources for developing ensemble climate scenarios, high-resolution models, and multiple emission scenarios for impact studies. Such an investment would enhance the capacity of the climate modeling community to generate and analyze model runs that are dedicated for use by impact analysts. Similarly, future assessments need to investigate a range of plausible emissions and atmospheric concentrations of carbon dioxide and other greenhouse gases. Enhancing the capability to generate dedicated scenarios of emissions and

climate would dramatically improve the range of outcomes that future assessments of vulnerability could analyze (NRC 1998b, 2001a).

3. INTERDISCIPLINARY STUDIES AND CAPABILITIES ARE NEEDED TO ADDRESS SOCIETAL NEEDS.

Recommendation 3.1: Develop regional enterprises designed to expand the nature and scope of climate services. BASC's twenty-first century report (NRC 1998a) recognized the importance of the expansion of the forecast family into the areas of water, air quality, and human health to serve national needs. *Our Common Journey* (NRC 1999c) argues for a framework that integrates global and local perspectives to shape a place-based understanding of the interactions between science and society with the objectives of mitigating threats to society and meeting basic human needs such as providing food and nutrition and ensuring air and water quality. It calls for more interactive linkages between those who create knowledge of the earth system, together with technology development, and those who use the knowledge to support decision making. *The Science of Regional and Global Change: Putting Knowledge to Work* (NRC 2001b) articulates a set of action items to ensure an "intimate connection" between research, operational activities, and the support of decision making and for regional and sectoral multiple-stress research to build decision-support capability. The overall vision of *Grand Challenges in Environmental Sciences* (NRC 2001c) suggests that the key to future environmental research will be to develop the capability to examine regions comprehensively to address a broad range of environmental problems and issues.

Those reports argue for transitions in the ability of science to serve society. At the core of each report is the notion that robust observation, data management systems, and forecasting and predictive capability can be expanded to serve decision makers better. Climate observations and climate forecasting and projection provide a foundation for the expansion of the observing and forecasting family, and hence the expansion of the family of services and products. Chapter 2, which describes the evolution of climate services in the United States, articulates a possible future of climate services that evolves from a weather service with an inherently short-term perspective to decision-centric climate services and eventually to environmental services that include climate information in the broader context of multiple stresses and spatial scales that range from local to global concerns. The recommendations suggest that the development of climate services in the United States should

include strategies that recognize that the future will bring a demand for services that focus on a multitude of problems rather than on specific disciplines.

A place-based imperative for environmental research stems from the importance of human activities on local and regional scales; the importance of multiple stresses, including climate, on specific environments; and the nature of the spatial and temporal linkages between physical, biological, chemical, and human systems. The strongest interaction between human activity, climate, and other environmental stresses is at the regional scale. Consequently, climate services, with a specific focus on regional problems and issues, can have their strongest intersection with decision makers. To address that need, the nation might begin to develop and fund a program of entities (laboratories or centers, either publicly, privately, or academically based) that emphasizes region-specific observation, integrated understanding, and predictive capability to produce useful information and focuses on addressing societal needs. Such laboratories or centers should be a part of the competitive, peer-reviewed research enterprise with the objectives of developing an integrated framework that will engender new avenues of research and application, catalyzing the development of useful products in service to society, bringing a demanding level of discipline to the full range of climate, and enabling investigation of a broad array of environmental issues through an enhanced capability at regional scales (NRC 1999c). These regional laboratories or centers are in many ways a regional subset of the objectives and guiding principles associated with climate services. As such, they should incorporate the elements of integrated observations, information systems, framework for supporting research, predictive products, and strong user interface described throughout this report:

Integrated observations. Current observations are often driven by different mission needs and tend to focus on the measurement of discrete variables at a specific set of locations. The observational systems are designed to serve the needs of weather forecasting, pollution monitoring, hydrologic forecasting, or other objectives. Recommendation 1.1 addresses the complex issues and challenges of creating integrated observing systems. However, a benefit of a regional focus is that the integration of complex sets of observations is manageable at this level, and the specificity of the problems and issues acts as an incentive for integration. That view is supported by current regional climate centers (RCCs) that demonstrate substantial value for a variety of users through the integration of a variety of data products. At a regional level, there is a potential to (1) link observing systems into a web of integrated sensors, building upon existing weather and hydrologic stations and remote sensing

capability, (2) formulate the agreements across a set of more limited agencies and federal, state, and local governments needed to create a structure for the observing system, (3) provide a compelling framework that encourages or demands the integration of new observations into a broader strategy, and (4) create strong linkages between research and operational observations that result in mutual benefit. The result is likely to create new efficiencies through the development of more comprehensive measurement systems that are more useful in enhancing the capabilities of RCCs.

Regional information systems. Society has amassed an enormous amount of data about the earth. Fortunately, technological innovations are allowing the capture, processing, and display of this information in a manner that is multiresolution and four-dimensional. The major challenges involve data management; the storage, indexing, referencing, and retrieval of data; and the ability to combine, dissect, and query information. The ability to navigate this information, seeking data that satisfy the direct needs of a variety of users, is likely to spark a new "age of information" that will promote economic benefit and engender new research directions and capabilities to integrate physical, biological, chemical, and human systems. A regional focus becomes a logical test bed, enabling the participation of universities; federal, state, and local governments; and industry in the development of a regional information system that is tractable and whose immediate benefit for a state or region can be evident.

Framework for process studies. Process studies are a critical element of scientific advancement because they are designed, through focused observations and modeling, to probe uncertainties in knowledge about how the earth system functions. In many cases, a mismatch between model predictions and observations can drive targeted investigations to limit the level of error. Frequently, efforts to couple different aspects of the earth system (e.g., the atmosphere and land-surface vegetation characteristics) prompt targeted exploration because the level of understanding is still rudimentary. The objective is to use field study to address deficiencies in understanding. The benefit of these intensive studies is maximized when they can be coupled with a highly developed, integrated set of sensors, with readily accessible spatial and temporal data within a regional information system and a predictive model framework that readily enables the entrainment and testing of new information from process studies.

Predictive capability. The value of reliable advanced information is widely recognized. Prediction is an important path for the translation of

knowledge into economic benefit and societal well-being. Over the last several decades there have been substantial increases in the ability to forecast weather and project climate and climate variability into the future. Enormous potential exists if the present mesoscale models can be coupled with improved regional mesoscale observing systems. Such a capability enables a strategy and implementation capability for building tractable coupled models, initiating experimental forecasts of new variables, assessing the outcomes associated with multiple stresses, and taking advantage of the discipline of the forecasting process to create a powerful regional prediction capability. Built on the numerical framework of weather and climate models, this capability could be extended to air quality, water quantity and quality, ecosystem health, human health, agriculture, and a host of other areas. Even in areas where predictive capabilities are not yet matured, or not forthcoming, such knowledge would allow decision makers to structure their decision processes in ways that are more independent of predictive information.

User-centric functions. By creating an observation, process study, and predictive capability that addresses multiple stresses in specific regions, the opportunity can be created to develop research capabilities that are tuned to the needs of users. At this scale, it would be possible to incorporate stakeholders and their decision-making needs at the outset and create a vigorous, cost-effective, and comprehensive intersection with knowledge and its use. Education, communication, outreach, and a continuous assessment process should be key requirements for a successful regional research enterprise.

The regional vision described above is designed to address a broad range of current and future environmental issues by creating a capability based on integrated observing systems, readily accessible data, and an increasingly comprehensive predictive capability. With demonstrated success over a few large-scale regions of the United States, this strategy will likely lead to a national capability that far exceeds current capabilities and permit the creation of a broader class of environmental services.

Recommendation 3.2: Increase support for interdisciplinary climate studies, applications, and education. It is essential to provide federal support to foster both the capacity for making and the ability to beneficially use climate products that are based on data, information, and knowledge from many disciplines (e.g., combining physical, chemical, biological, and societal stressors to yield products that show climatological variability and societal impacts). That support should be developed as a direct element in support of

mission agency objectives and as a part of the objectives of independent, exploratory research agencies. The existing climate-related observing, modeling, and service and product-providing capacity in the United States is a foundation on which to build, as is the existing federal, state, and local support funding infrastructure. However, those structures also present challenges. *Our Common journey* (NRC 1999c) describes the need to integrate disciplinary knowledge in place-based, problem-driven research efforts and notes that this need runs counter to deeply held organizational biases in academe and government: "Thus, it is vastly easier to mount a study of the people or plants or hydrology or soils of a watershed than of their interactions." Consequently, it is rare to encounter integration of physical, biological, social, and health sciences in any phase of climate studies and services, from basic research to observations to interaction with users. *Our Common Journey* calls for putting more funds into the hands of place-based institutions with a mission of promoting policy-driven knowledge and know-how. In moving forward for climate-related services, attention should be paid to developing the infrastructure and staffing needed to develop and synthesize climate products based on diverse data sets. This recommendation follows directly from the guiding principle for climate services that if a climate service function is to improve and succeed, it should be supported by active research. It also requires support for education and training, for research on developing applications across disciplines, for identifying what products to produce, and for data sharing and serving and modeling infrastructure. At the same time, the ability and appetite to use climate products that provide syntheses across disciplines should be built by outreach to and education of users. At present, proposals for multi-disciplinary climate research are difficult to fund in that they fall across too many different agencies. It is recommended that a mechanism for soliciting, reviewing, and funding such studies be put in place as soon as possible. Such a mechanism could be modeled after the National Oceanographic Partnership Program that is beginning to show progress across the public-private-academic interfaces.

Recommendation 3.3: Foster climate policy education Climate science has become increasingly interdisciplinary, involving meteorology, oceanography, terrestrial physics, and biology. Consequently, climate education should be more interdisciplinary. Climate services inherently involve inter-facing climate science with user communities in such areas as agriculture, energy, public health, and government. The evolution of climate services will

provide an increased demand for people who have training in both climate science and the social sciences. Universities should therefore initiate majors and minors in climate policy to enable informed planning and management of climate services. Such programs should include education in the basics of climate science, identifying the needs of various user communities and creating and disseminating useful climate information for them. This recommendation follows the education and outreach mission of universities under the guiding principles for climate services (see Chapter 3).

Recommendation 3.4: Enhance the understanding of climate through public education. Climate is increasingly important in the decisions made by individuals, corporations, cities, states, and the nation as a whole. Critical to the successful application of climate information is an educated consumer. The basis of predictions, understanding of uncertainties, and an ability to communicate probabilities are key elements in enhancing the benefit of climate information. Outreach and education are key elements of developing a strong climate service in the United States. *The Science of Regional and Global Change* (NRC 2001b) states that fundamental change will be possible only if education and outreach efforts communicate the progress of understanding: "The quality, diversity, inclusiveness, and timeliness of education and outreach efforts are probably the most important factors determining success or failure in the long run." BASC views this recommendation as directly responsive to the guiding principle for climate services: "Greater education of the user in the meaning and significance of climate information is likely to promote greater use and more robust application of that information" (NRC 2001b).

CONCLUDING REMARKS

BASC did not explicitly explore a formal climate services organizational structure within a specific federal, state, or local agency. Several proposals internal to the government have been made in the past. For example, the *NOAA Climate Services Plan* (Changnon et al. 1990) offers several suggestions for consolidating NOAA climate organizations, the Climate Prediction Center and the National Climatic Data Center, with the RCCs to form a unified climate service. However, an evaluation of such plans is outside the scope of this report. Instead, BASC reviewed current climate services and their potential evolution. The existing network of state climatologists, RCCs, national agencies, and private sector organizations has provided services in the past and

provides increasingly competent services today. BASC believes that the principles discussed in this report represent the best practices of the various activities and that if applied across all levels of services—local, state, regional, and national—would improve the overall climate services to the nation. The recommendations contained in this report offer concrete first steps to a better integrated national system.

Dr. Lean is a member of the American Geophysical Union and the American Meteorological Society.

MARGARET A.LEMONE is a senior scientist at the National Center for Atmospheric Research (NCAR). She has two primary scientific interests: the structure and dynamics of the atmosphere's planetary boundary layer and its interaction with the underlying surface and clouds overhead, and the interaction of mesoscale convective with the boundary layer and surface underneath, and with the surrounding atmosphere. Dr. LeMone is a Fellow of the American Association for the Advancement of Science and the American Meteorological Society. She is also a member of the National Academy of Engineering (NAE) and has served on the National Research Council's Panel on Improving the Effectiveness of U.S. Climate Modeling and the Special Fields and Interdisciplinary Engineering Peer Committee of the NAE. Dr. LeMone received her Ph.D. in atmospheric sciences from the University of Washington.

MARIO J.MOLINA is a professor at the Massachusetts Institute of Technology. His interests are common to the fields of atmospheric chemistry, chemical kinetics, and photochemistry. His research is directed at understanding the potential implications of changes in the chemical composition of the earth's atmosphere and aims to elucidate the role of aerosols and clouds in the changing chemistry of the global atmosphere. In 1995 he shared the Nobel Prize in Chemistry with two co-investigators for their work in demonstrating

the link between man-made chlorofluorocarbons in the atmosphere and the damage to the ozone layer. Dr. Molina is a member of the National Academy of Sciences and the Institute of Medicine. He has served on the President's Committee of Advisors on Science and Technology, the Secretary of Energy Advisory Board, and on several National Research Council committees, including the Board on Environmental Studies and Toxicology and the Committee on Atmospheric Chemistry. Dr. Molina received his Ph.D. in physical chemistry from the University of California, Berkeley.

ROGER A.PIELKE, JR. is an Associate Professor in the Environmental Studies Program and a Fellow of the Cooperative Institute for Research in the Environmental Sciences (CIRES) at the University of Colorado, Boulder. He is overseeing the development of a new Center for Science and Technology Policy Research. Previously, Dr. Pielke was a scientist at the National Center for Atmospheric Research where he studied societal responses to extreme weather events, policy responses to climate change, and U.S. science policy. With a B.A. in mathematics and a Ph.D. in political science, he focuses his research on the relation of scientific information and public and private sector decision making. His current areas of interest include technology policy in the atmospheric and related sciences, use and value of prediction in decision making, and policy education for scientists. Dr. Pielke chairs the American Meteorological Society's Committee on Societal Impacts and serves on the Science Steering Committee of the World Meteorological Organization's World Weather Research Programme. He sits on the editorial boards of *Policy Sciences, bulletin of the American Meteorological Society*, and *Natural Hazards Review.* He is a co-author or coeditor of three books, most recently *Prediction: Decision making and the future of nature.*

MICHAEL J.PRATHER is a professor in the Earth System Science Department at the University of California, Irvine. He received his Ph.D. in astronomy from Yale University. His research interests include the simulation of the physical, chemical, and biological processes that determine atmospheric composition, specifically ozone and other trace gases. Dr. Prather has authored chapters in the World Meteorological Organization's Ozone Assessments (1985–1994) and the IPCC's assessments of climate and aviation effects (1995– 2000). He is a fellow of the American Geophysical Union and a foreign member of the Norwegian Academy, and has served on several National

Research Council committees, including the Panel on Climate Variability on Decade-to-Century Time Scales.

WILLIAM J.RANDEL is a senior scientist at the National Center for Atmospheric Research. His research interests include dynamic variability and climatology of the stratosphere and the observed variability of trace constituents in the middle atmosphere using satellite observations. He has contributed to the World Meteorological Organization/United Nations Environment Programme (WMO/UNEP) Assessments of ozone and temperature trends in the stratosphere and is actively involved with a number of Stratospheric Processes and Their Role in Climate (SPARC) activities. He has also served as chair of the American Geophysical Union's Committee on Atmospheric Dynamics and the American Meteorological Society's Committee on the Middle Atmosphere. Dr. Randel received his Ph.D. in physics from Iowa State University.

ROBERT T.RYAN is Chief Meteorologist at WRC-TV (NBC 4) in Washington, D.C. He received his Masters in atmospheric sciences from the State University of New York, Albany. Prior to his career in broadcasting, he was a research associate in the Physics Section at Arthur D.Little where his work involved various cloud physics projects with the Department of Defense. He was also involved in various meteorological field experiments for NASA and the U.S. Army. Mr. Ryan is nationally and internationally recognized for his outreach and educational activities in meteorology and atmospheric sciences. He was the first broadcast meteorologist elected to serve as president of the American Meteorological Society (AMS). He has also served the AMS as Councilor, Commissioner of Professional Affairs, and Chairman of the Board of Broadcast Meteorology. In 1997, Mr. Ryan received the Charles Franklin Brooks Award for service to the Society. He has also served on various AMS, NASA, and NOAA study groups, testified a number of times before Congress, and is the winner of nine Emmy awards for his television productions and service to the community. He is a fellow of the AMS and a member of the American Association for the Advancement of Science.

MARK R.SCHOEBERL is a senior atmospheric scientist at NASA's Goddard Space Flight Center. He received his Ph.D. in physics from the University of Illinois. He has also served as a scientist at Science Applications, Inc., and at the Naval Research Laboratory. His fields of research include atmospheric dynamics, stratospheric physics and chemistry, and numerical modeling. He is

the EOS-Aura Project Scientist. Dr. Schoeberl has received many NASA awards, including the Group Achievement Award in 1988, 1989, 1991, 1994, 1995, and 1998, and the Education and Outreach Award in 1999. In addition he was awarded the Scientific Achievement Medal in 1991, the Distinguished Service Medal in 2000, and the William Nordberg Award for Earth Sciences in 1998. He is a fellow of the American Geophysical Union (AGU) and past president of the AGU's Atmospheric Sciences section. He is also a fellow of the American Association for the Advancement of Science and the American Meteorological Society.

JOANNE SIMPSON is Chief Scientist for Meteorology and Senior Fellow at NASA's Goddard Space Flight Center. She received her Ph.D. from the University of Chicago and an honorary D.Sc. from the State University of New York, Albany. She has served on the faculty at the University of California, Los Angeles, and at the University of Virginia. She was also head of the atmospheric physics and chemistry laboratory at ESSA, director of NOAA's Experimental Laboratory, and head of the severe storms branch at NASA Goddard. Her areas of research include atmospheric convection, tropical meteorology, weather modification, and satellite meteorology. Dr. Simpson is a member of the National Academy of Engineering and a fellow and honorary member of the American Meteorological Society (AMS). She has received many awards, including the Charles Franklin Brooks Award and the Meisinger Award from the AMS, the Rossby Research Medal, the Silver and Gold Medals from the Department of Commerce, and NASA's Exceptional Scientific Achievement Medal and William Nordberg Award. She has served on several National Research Council committees including the Committee on Climate, Ecosystems, Infectious Diseases, and Human Health.

THOMAS F.TASCIONE is Vice President, Weather Systems Operations, Sterling Software (U.S.), Inc. In this position he oversees the development of a state-of-the-art weather forecasting technology for the Defense Department. In addition, he manages a commercial space weather forecasting service to support the commercial satellite and electric power industries. Another focus area is advanced weather visualization technology for aviation including a patented system to extract and apply weather information along a route a flight using a simple web-browser. His prior professional experience was with the Department of Defense (1972–1993), during which he held numerous weather and space weather forecasting positions. He was the architect of the Air Force

space weather forecast models program, and he co-chaired the interagency committee that initiated and developed the National Space Weather Program (NSWP). Dr. Tascione received his Ph.D. in space physics from Rice University.

ROBERT A.WELLER is a Senior Scientist at Woods Hole Oceanographic Institution, where he holds the Secretary of the Navy/CNO Chair in Oceanography and is Director of the Cooperative Institute for Climate and Ocean Research. He received his Ph.D. in Physical Oceanography from the University of California, San Diego, Scripps Institution of Oceanography. His research interests include wind-forced motion in the upper ocean; mixed layer dynamics; upper ocean velocity structure studies; air-sea interaction; the role of the ocean in climate; and the development of upper ocean and surface meteorological instrumentation and platforms for air/sea experiments. Dr. Weller received the James B.Macelwane Award from the American Geophysical Union (AGU) in 1986. He is a fellow of the AGU and president of the Ocean Sciences section. He is also a member of the American Association for the Advancement of Science, the American Meteorological Society, and the Oceanographic Society.

ERIC F.WOOD is Professor of Civil and Environmental Engineering at Princeton University, where he has taught since 1976. He received his Sc.D. in civil engineering from the Massachusetts Institute of Technology. His areas of research include hydroclimatology with an emphasis on land-atmospheric interaction, hydrologic remote sensing, and hydrologic impact of climate change. Dr. Wood is a member of the National Research Council's Climate Research Committee and Committee on Hydrologic Sciences. He is a member of the Council and a fellow of the American Meteorological Society (AMS) and a fellow of the American Geophysical Union (AGU). He has received the AGU Robert E.Horton Award, the AMS Horton Lectureship, and the Princeton Rheinstein Award.

This study will:

- Define climate services.
- Describe potential audiences and providers of climate services.
- Describe the types of products that should be provided through a climate service.
- Outline the roles of the public, private, and academic sectors in a climate service.
- Describe fundamental principles that should be followed in the provision of climate services.

The workshop will include a broad array of both providers and users of climate information. An informal discussion paper that outlines fundamental issues concerning the provision of climate services will be prepared in advance of the meeting.
